# TO KNOWLEDGABLY PRACTICE CONVERSATION...

# CITE

ALL CONTRIBUTING WORK OF OTHERS IN YOUR OWN INFORMATION PRODUCTION

# CONTRIBUTE

TO THE CONVERSATION AT APPROPRIATE LEVELS, INCLUDING ONLINE COMMUNITIES, RESEARCH JOURNALS, OR CONFERENCE PRESENTATIONS

### IDENTIFY

BARRIERS TO ENTERING SCHOLARLY CONVERSATION VIA VARIOUS VENUES, I.E. EDUCATION ACCESS, INTERNET ACCESS, IN-PERSON CONNECTIONS

### SUMMARIZE

WHAT HAS CHANGED WITHIN THE SCHOLARLY CONVERSATION OVER TIME THROUGH RESEARCH AND CONDUCTING LITERATURE REVIEWS

### RECOGNIZE

THAT ONE SCHOLARLY WORK DOES NOT REPRESENT THE MAJORITY ON A GIVEN ISSUE

# TO MAINTAIN SCHOLARLY DISPOSITION IN CONVERSATION...

# ACKNOWLEDGE

YOU ARE ENTERING A CONVERSATION THAT IS BOTH ONGOING AND INDEFINITELY UNFINISHED

# SEEK

OUT THE CONVERSATIONS TAKING PLACE IN YOUR RESEARCH AREA OF INTEREST

# MEW

YOURSELF AS A CONTRIBUTOR TO THE SCHOLARSHIP, NOT JUST A CONSUMER OR VIEWER OF IT

# SUSPEND

JUDGMENT ON A PIECE OF SCHOLARSHIP UNTIL THE ENTIRE CONTEXT OF THE CONVERSATION IS UNDERSTOOD.

# RECOGNIZE

THAT SYSTEMS PRIVILEGE SPECIFIC VOICES AND AUTHORITIES AND THAT NOT HAVING FLUENCY IN THE LANGUAGE AND PROCESS OF A DISCIPLINE DISEMPOWERS OPPRESSED VOICES' ABILITY TO ENGAGE
